ANSWERS TO QUESTIONS RAISED BY CONTRACTORS

- Q1. There are two scheduled shutdowns in February and March. Which equipment/ areas would be available for testing and maintenance? This will help us to estimate required man-hour and resource mobilization.
- A1. The tentative scheduled for equipment shut down times are:
- During **regular hours** as prearranged with EGD Operations and Crane Operations;
 - HV Ship-Shore Service
 - 150 Tonne Crane
 - North Side 30 Tonne Crane
 - South Side 30 Tonne Crane
 - During First Shut-Down **Feb. 28 – Mar. 01**:
 - Main Substation Building
 - DND Feeder including 12.5kV main feed cables from DND isolation switch
 - Pumphouse Building **NOTE:** Pumphouse runs the auxiliary dewatering pumps, which may require to be re-energized mid-service.
 - North Generator Building
 - 120 VDC Battery Station
 - All High Voltage Cables related to the above.
 - During Second Shut-Down **Mar. 07 – Mar. 08**:
 - North Landing Wharf Substation Building
 - South Side Substation Building
 - South Compressor Room
 - All High Voltage Cables related to the above.
- Q2. Do you have any list of current deficiencies? There is a list of deficiencies in appendix A, and we understand that corrective actions were taken on those issues.
- A2. A list of remaining repairs and modifications to bid on can be found in Section 26 08 01, Paragraph 3.3 MINOR MODIFICATIONS AND REPAIR WORK.
- Q3. Are we allowed to take pictures of all the deficiencies during the proposed site visit?
- A3. Pictures are allowed of electrical equipment barring any photos that have Military vessels in the back ground.
