**Question:** On page 22 of the above noted RFP, Section 6. Reports and Deliverables states in the first paragraph: "An interim report will be required sometime between contract start and 26 February 2015...".

Please clarify the date - we are assuming 26 February 2015 should be 26 February 2016.

**Answer:** On page 22 of 33, Annex "A", Statement of Work, Section 6. Reports and Deliverables:

**DELETE the following sentence:**

An interim report will be required sometime between contract start and 26 February 2015 and should be submitted in electronic form by the contractor.

**INSERT the following sentence:**

An interim report will be required 6 months from date of contract award.

If your proposal has already been submitted, you may wish to revise it. Revisions to your proposal must be submitted in a sealed envelope with the contents clearly identified on the outside of the envelope. Any revisions to your proposal must be received by the Bid Receiving Unit on or before the time and date stated on page 1 of this document.
