#### SECTION R4 – SUB-SECTION R.4.1.a.2

*In this section, the "Bidder should provide copies of the ISO work procedures relevant to each phase of the requirement – warehousing/inventory management, order processing, customization using inkjet process, order fulfillment, and distribution or printed items as described in the Statement of Work. Should the Bidder propose to utilize multiple facilities, each holding ISO certification relevant to this requirement, a copy of the ISO work procedures relevant to the work completed in the facility should be submitted with the proposal."*

We will be submitting ISO certification. However, due to the voluminous amount of material developed for each SOP, for the purposes of this evaluation, would PWGSC and TCCA be willing to accept a comprehensive list of all relevant SOPs? In addition, and also as part of the rated evaluation process, would PWGSC and TCCA be prepared to visit to our facility to allow PWGSC and/or TCCA the opportunity to review the documents on our premises?

In the table, point number 2 requests information regarding "*Rainbow Printing*" while in point number 4 in the table, requests information regarding "*Rainbow (prismatic printing)*". In the realm of security printing and ICAO, the terms of "Rainbow" and "Prismatic" and interchangeable terminology.

For the purposes of clarity, are these to be considered the same type of printing for this response?

The Bidder is requested to clearly describe its manufacturing infrastructures particular for the "*Printing of a security seal unique to Transport Canada of specified pages.*"

This is a similar reference to one previously found in the Statement of Work for Stream A and also in Annex E - Section M.1, Sub-Section - M.1.3 - Point a).

It is unclear which specific feature this request is referring to as we are unaware of this type of feature appearing in the current ADB. For clarification purposes, could information please be provided as to which feature/ type is specifically being referred to?

**Response 22:**

Refer to Fig. A-4 – Pre-Printed Stock Prior to Personalization and Fig. B-3 – Customized Label on Carrier Sheet (Annex A Statement of Work - Stream A), as it depicts the TC security seal (round circle with aviation emblem)

**Question 23:****PART 6 – SECURITY AND FINANCIAL REQUIREMENTS****Part 6.1 – Security Requirements - Point #2**

In this section the requirement states “Before award of a contract the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites.”

The nature of this requirement would necessitate us providing the names of virtually every employee working within our facilities, which would be in excess of several hundred individuals.

**Response 23:**

This is a requirement of PWGSC/CIISD. As such, before award of contract, the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites.

**Question 24:****ANNEX “A” - STATEMENT OF WORK – Stream A****Section 1.1 - ADB - Sub Section 1.1.2 Printing Specifications**

Can TCCA/PWGSC please confirm if the Contractor will have to apply medical correction labels to the current design of the ABD as under the “General Specification” it states that “*the ADB is to be an exact copy of the existing ADB*”? Or, will a change to the design be implemented prior to the next production run that will change the actual table in the ABD’s design for the future?

**Response 24:**

Any existing ADBs will have to continue having the Contractor’s personnel apply the label over the original table. A change to the design will be implemented before the next production run so that the table reflects the new information that currently shows on the label.

**Question 25:****ANNEX “A” - STATEMENT OF WORK – Stream A****Section 1.1 - ADB - Sub Section 1.1.2 Printing Specifications**

In Annex A, it states “*Printing of a security seal unique to Transport Canada on specified pages.*”

Would TCCA / PWGSC be able to clarify which feature is currently referred as a “security seal unique to Transport Canada” and on which pages of the ADB this feature can be seen? Are we to interpret this as a change in the design?

**Response 25:**

The security seal referred to is a part of the current design.

Based on the description, we believe that this is, or should be, focused on Stream B as it is not relevant to the Stream A requirements.

For the purposes of this evaluation, would PWGSC consider removing and/or ignoring this specific Item (j) requirement?
