The purpose of this amendment is to respond to Bidder's questions and to make the revisions indicated in Part B of this solicitation amendment:

PART A – RESPOND TO BIDDER'S QUESTIONS

Question 27:

In response to two previous inquiries, the response denoted that in the case where a Contractor was successful in being awarded the contract for both Stream A and Stream B, shipment of the finished ADBs and ADLs to Transport Canada Distribution Centre would still be required.

Would PWGSC/TCCA consider relieving this requirement if both contracts are awarded to one (1) Contractor?

Response 27:

No. If the same vendor is chosen for both Stream A and Stream B, then TCCA will determine and provide the necessary level of stock needed for a four-month period to sustain operations for Stream B.
