**TITLE: RENTAL VEHICLES IN MIRAMAR, CALIFORNIA**

This solicitation amendment is to provide for clarifications regarding the Request for Proposal (RFP).

- Q1. Am I to utilize the "block of vehicle calendars" from the original bid in order to determine days, weeks and months each vehicle type will be rented? Or may I provide my estimated totals based on a 36 day rental for each vehicle, in each category?
- A1. The "block of vehicle calendars" indicate how many vehicles of each category are required on each given day over the 36 days. The bidder should provide their best estimated price taking this information into consideration.
- Q2. In order to provide an accurate quote, I created an amended table for Annex, "B," – Basis of Payment. May I submit this with our bid in place of the table originally included in Amendment 1? If so, how should I submit it? Should I reference, "see attached," under Annex, "B?"
- A2. "The Financial bid must be [...] in accordance with the Basis of Payment." (Section II: Financial Bid, page 5 of 17). You do not have to submit an actual hand-filled copy of Annex "B". If you have reproduced it, e.g. Excel spreadsheet, you may submit a copy of that.
- Q3. The pick-up truck calendar on page 15 of the original bid request does not clarify which of the trucks ( ½ ton vs. ¾ ton w/hitch) is needed from 13 Feb – 16 Mar and which are needed 10 Feb – 17 Mar. Can you please clarify.
- A3. 2 x trucks without hitch: 10 Feb – 17 Mar; and 1 x truck with hitch: 13 Feb – 16 Mar.
- Q4. Annex, "C," – Car Rental Company Information. 2. Rental Company Information: Do you require the branch location where the vehicles will physically be rented/delivered from or do you require the corporate office location where the tax ID is from?
- A4. Please provide information for both locations.
