**ANSWERS TO QUESTIONS RAISED BY CONTRACTORS**

- Q1. What is the size of the gasket of the drain plug? (item 6 in Section 26 08 01, Paragraph 3.3 MINOR MODIFICATIONS AND REPAIR WORK.).
- A1. There are no accurate manufactures shop drawings available for this gasket of the drain. Site measurements must be taken before gasket is ordered and installed.
- Q2. What is the make and model number of the transformer temperature sensor? (Item 4 of the above section)
- A2. The face place of this temperature sensor states "Winding Temperature Indicator, Model RW, Teston Gauge Limited, Toronto".
- Q3. Item 5 mentions here to replace a high voltage insulator of main substation 208 volt transformer? Are you referring to the transformer with the serial number S7851.01 and manufactured by FPE? Do you have the dimension of the insulator and any associated drawings? (Please see attached).
- A3. Item 5 refers to the Main Substation 208 volt transformer with the serial number S7851.01 and manufactured by FPE. Drawing and dimensions not available but can be measured on site.
- Q4. Can we schedule to conduct the maintenance of the following areas between the scheduled shutdown periods February 28- March 1 and of March 7-8, 2015?
- HV Ship-Shore Service
  - Tonne Crane
  - North Side 30 Tonne Crane
  - South Side 30 Tonne Crane
- A4. The dates between these scheduled shut-down periods are available for maintenance on the above equipment. These dates however, are subject to changes depending on the dock operations at that time. Actual dates for maintenance during normal hours will be verified and approved in advance.
- Q5. Appendix A - Part 02 11x17' and 'Appendix B - Part 02 11x17' are the same documents. Please clarify if otherwise.
- A5. The "Relay Setting versus coordination study" in Appendix A and B are the same document.

- Q6. 'Appendix C - Part 02 11x17' drawings are ineligible. When blowing the drawings up to a workable size the line definition is lost. Please reissue Appendix C in a pdf format from a good quality source rather than a photocopy. Much appreciated.
- A6. The drawings in Appendix C will be reissued as downloadable PDF files.
