This amendment is raised to address the following:

- To respond to questions received during the solicitation period;
- To revise the solicitation accordingly.

### **QUESTIONS AND ANSWERS**

Q1: Would a tunnel opening of 650mm x 450mm be acceptable?

A1: No. The tunnel opening must be a minimum of 750mm (W) x 500mm (H) due to large packages received. See amendment to solicitation below.

Q2: Would a system width of 1734mm and height of 1959mm be acceptable since the unit only needs to fit into an enclosure of 5918.2mm length x 4318.0 width?

A2: The overall height can be increased to 3000mm, but the remaining specifications outlined in 2.3 remain unchanged. The additional space is for non-related equipment. See amendment to solicitation below.

Q3: Is there a specific size door that this unit needs to fit through in order to arrive at its mailroom destination? If so, what are the dimensions?

A3: Yes. Garage Door Opening: The size of the opening is 3657 mm (W) x 3657 mm (H) or 12 " x 12"

Q4: At 2.2.1, would the supply of two 19" LCD monitors with 1440x900 screen resolution be acceptable?

A4: No. Two 20" color LCD monitors with 1280 x 1024 resolution are required.

Q5: At 2.3, can the overall dimensions be modified to allow for larger units as per the following: Length: 4800mm, Width: 2000mm; Height: 2100mm? As stated in 2.3.6, these modified dimensions would still easily fit within the enclosure.

A5: The overall height can be increased to 3000mm, but the remaining specs outlined in 2.3 remain unchanged. See answer 2 above and amendment to solicitation below.

Q6: At 2.5.3, the industry standard specifications, i.e. IEC Standard IEC 61000-4-4:2012 (Electrical Fast Transient Burst) are listed below:

- +2kV pulse of 50nS duration at every 0.2mS for 15mS. The burst of pulses repeat every 300mS for 60S
- b) -2kV pulse of 50nS duration at every 0.2mS for 15mS. The burst of pulses repeat every 300mS for 60S

As these specifications are an industry standard, can you please confirm that this would be acceptable?

A6: The equipment must meet the industry standard for the Electrical Fast Transient/Burst.

Q7: At 2.9.2, our proposed system can export images in our proprietary format and these can be reformatted into various formats (jpeg, bmp); would this be acceptable as it allows for the flexibility of various file formats?

A7: The unit must be capable of exporting or reformatting images in multiple common data formats (e.g. JPEG, BMP). See solicitation amendment below.

Q8: At 2.9.8, Would a non-stepless zoom be acceptable as the functionality of the zoom feature remains the same?

A8: The unit must have a zoom overview and stepless or non-stepless zoom. See solicitation amendment below.
