The solution should have the ability to monitor significant events and incidents of a managed service/target related to an existing problem. The solution should have the ability to monitor events such as availability alerts, errors triggered by applications, and job events associated to a known problem, and should have problem reporting functions.
2	Ref: Request for Information Annex A, Draft Statement of Requirements, Section 4, "Functional Requirements", Requirement 7(a): Can PWGSC clarify or provide an example of what is meant "quality control/assurance mechanisms?"	The solution should have an approval change authorizations process, continuous monitoring of assets, role based control or other mechanisms to ensure the integrity of the assets and configurations items of CMDB. Ex: If an asset is sent to surplus and needs to be archived in the system, it should go through an approval process and only an identified group of employees with privileges should be able to proceed with the change of asset status.

The system should be able to configure user information organizational information breakdown such as

The solution should have the ability to monitor privileged role assignments and inspect administrator groups and other system related accounts on demand to ensure that unauthorized accounts have not been created/modified.

The solution should have the ability to configure multi support groups based on business operations or support groups across multiple locations, different time zones, working hours and holidays.
