This Solicitation Amendment 001 is raised to answer Bidder's questions and amend the delivery date on the front page and in the French document.

Questions and Answers

Q1- Is there a drawing available that shows the Gantry you are looking for with dimensions?

A1- There is no drawing available for the Gantry.

Q2- The specification states adjustable width, to 35 feet, what is the condensed size?

A2- No specific condensed size.

Q3- The specification states height adjustable from 15' 8" to 23 '8". Are you referring to the height of lift of the hoist, or they want the height of the beam lifted and lowered within these dimensions?

A3- Total height of the crane.

Q4- Wheels are to be manual only with swivel lockable casters, kindly confirm? Basically non-motorized?

A4- Confirm manual wheels, swivel lockable casters. Crane to be non-motorized.

Q5- We assume this unit will be moved around, do you want a length of power cable mounted on a retractable cable reel and what length of power cable to you require? Reel can be mounted on the Gantry.

A5- Crane will be moved around. Power cable does not have to be on a retractable cable reel. Length of power cable – min 75 ft.

Q6- In the appendix, it's write "pose de la grue". Do we need to assemble / install it in Borden? If yes, do we need some special accreditation or training to work on your site?

A6- Assemble and install at Borden. No special training required. Orientation briefing, including security and safety brief, will be given by our staff. Workers must be accompanied by an escort.

Q7- For your 6 & 12 month maintenance, do we need training to work on your site?

A7- Orientation briefing, including security and safety brief, will be given by our staff. Workers must be with an escort.
