1.3. Software

DND will provide all necessary software to carry out the work being tasked to the Contractor. This includes but is not limited to:

- . Workstation software required to perform tasks
- . All necessary software licences to run the provided software

2. Hardware Environments

2.1. Workstations

Workstations will be provided for the contractor's facility to allow them to perform their tasks. The suggested configurations for these workstations are as follows:

2.2.2. Server Room Requirements

The Server Room must be adequately constructed to house and operate the list of provided items in Section . This includes:

- . Equipped to deal with a potential fire in the room.
- . Adequate cooling (Air Conditioning) and ventilation to operate the provided hardware at the recommended performance specifications.
- . Adequate capacity and quality of electrical systems to support all the hardware powered on and running at the recommended performance specifications.
- . Abide by all building codes for a room that houses equipment of this nature.
- . Equipped with a locked door to limit access to the room.
