Question 3.

We are a qualified supplier under the SO and SA E60ZH-070003 / F, and we are currently preparing a response to the refresh of the RFSA E60ZH-070003/H to provide a new service stream. However, we have some questions about the documentation required for submitting an application for a stream and/or an additional resource category.

More specifically, for the technical bid, are we only required to fill in the Excel document titled "Technical Response Template (FR)" and complete the required fields in the DCC? Do we also send CV proving that our resources meet the requirements listed in Appendix A? Also, what are the additional documents we must provide to meet the "Requirement M.2 (h)" (page 14 of the document, ADD)?

Response 3.

Existing Suppliers who wish to add categories or streams to their existing SA must complete the required fields in the DCC and submit the hard copy of the Technical Response Template.

The additional information referred to in the grid on Page 14 is the information required on the Technical Response Template. It is not required to submit CV's for resources as only the projects are evaluated, not the individual resources.
