Special Instructions to Bidders

- Q1. At Station 13+580, 13+860 & 16+110 it is hard to determine the exact location of the pipes to be replaced. Can the culvert be marked with a survey stake and ribbon?
- A1. The five culverts included in the tender have been marked on site with a stake flagged with blue and pink ribbon. Each stake is located over the culvert adjacent to the northbound lane. The culvert locations can further be located using the coordinates listed below, and the attached map.

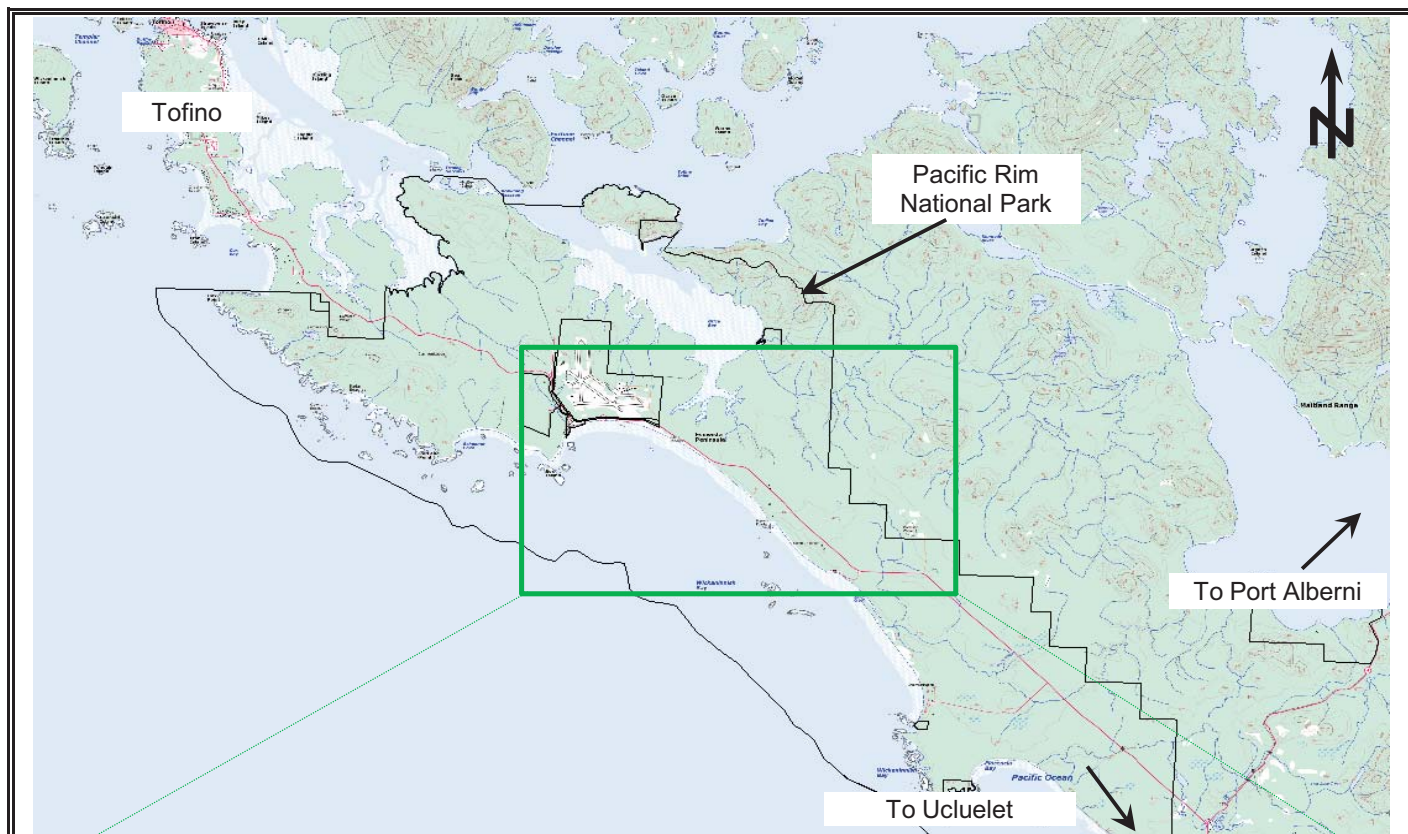
