2.0 Questions and Answers

Q15. Will the footings be required to drop below the intake pipe lines as per detail 10/C06? If so, then that would make the foundation walls much deeper than what is shown on the structural drawings.

A15 The underside of footings will be located 1200 below finished grade for frost cover. The pipe will run under the footing into the building. Detail for that condition on sheet S01.

Q16. No fire alarm system is shown, is one required?

A16. No fire alarm system required by NBCC.

Q17. No electrical shown for the duct heaters shown on the mechanical drawings.

A17 Answer as provided in Q14 (Amendment 002)

Q18. No exit signs are shown, are they required?

A18 Add an exit sign above each door.

Q19. No grounding system is shown, one would be expected for items like the unit heaters and building siding.

A19 Grounding is provided by the bonding conductor run with the service under the provision of the CEC 10-208 (b). Also a bond wire is run to each heater. The siding does not need to be bonded.

Q20. Are there ground fault receptacles or breakers for wet locations?

A20 This is not a wet location as defined by the electrical code. No receptacles are in proximity of sink.

Q21. Conduits are shown for instruction and EMCS but no wiring details are provided.

A21 Answer as provided in Q5 (Amendment 002).

All other terms and conditions remain the same.
