Question 27

In reference to Annex B, one page references Mississauga, Hamilton, and London Ontario. On this page it says:

NOTE: Bidders are not required to bid on all Locations. Separate contracts will be awarded for each location.

Does this mean a Bidder could just bid on the Mississauga office, only?

Answer 27
