This Solicitation Amendment is raised in order to:

(i) Answer the following questions:

Question 1: Can the client please confirm if there are incumbents currently providing the services described in the RFP? If so, please provide the value and duration.

Question 2: Is there now, or has there ever been, a contractor or contractors delivering to services similar or identical to those being solicited within this RFP? If so, who is the Vendor, what is the length of the contract (start/end dates) and what is the overall value of the contract or contracts included in the delivery?

Answer for 1, 2: Yes, there are contracted resources providing the services as described in the RFP. Contract value = \$8,267,2122.60. Contract duration = three years, plus two option years – Contract W8485 -125519/001/ZM.

Question 3: This RFP requires that the vendor holds authorization as an “authorized Axios assyst Service Provider”. Could the Crown kindly identify any such authorized firms within the NCR?
