SOLICITATION AMENDMENT 005

This amendment is raised to incorporate the following questions and answers:

Question 37: Please confirm that Bidder members of a joint venture must each be registered in, and fully compliant with, the Controlled Goods Program (CGP).

Please refer to Article 6.1v) of the RFP which states: ***"In the case of a joint venture Bidder, each member of the joint venture must meet the security requirements."***

Question 38: Would a company be found compliant if they were to utilize the experience from all entities whom are part of this bid? This is not a Joint Venture but rather several companies under a teaming agreement (one company leading) organizing themselves to service this requirement in the best possible light.

No, they would be deemed non-compliant. The Bidder must demonstrate their experience or they will be considered non-responsive.
