THIS AMENDMENT #005 IS RAISED TO ANSWER QUESTIONS FOR THE RFSA**QUESTIONS AND ANSWERS****QUESTION 009:**

We are an Aboriginal Company, who is in business over 17 years, qualified for TBIPS and TSPS but mainly operated in the Toronto Area serving the Provincial Government and large private sector companies. We have set up a Branch Office in Ottawa and we hope to extend operation and provide service to the Federal Government. We are planning to submit our proposal to qualify for THS at the end of June, 2015

We have reviewed the subject RFP and we have a question regarding the Suppliers Mandatory Requirements M2A and M2B and may be M2C. The requirement calls for "...services of the above 20 compliant temporary help resource names must have been billed to a minimum of 3 different clients located in the National Capital Area"

- a) Please confirm that it is acceptable to the Crown if the named resources may not have provided the services under our company name.
- b) Alternatively, would the Crown consider extending the territory and include the province of Ontario and Quebec.

ANSWER 009:

- a) Services rendered by the temporary help resource(s) must have been provided under the named bidder. Bidders may provide temporary help resources that were placed on a temporary assignment, and/or still on assignment and/or who are permanently placed in order to demonstrate how they meet the mandatory requirements of the RFSA solicitation EN578-060502/I. The Bidder must demonstrate that the resource worked a minimum of 37.5 hrs for which the Bidder received payment. As stated in Attachment 1 to Part 4, Mandatory Evaluation Criteria, M2A, M2B and M2C: In order for a resource to be compliant: "Each resource must have worked a minimum of 37.5 hours between Date X and solicitation closing date inclusively **rendering services for which the Bidder received payment.**"
- b) This RFSA EN578-060502/I solicitation is an opportunity for new suppliers to provide Temporary Help Services in the National Capital Area only. Bidders can view THS solicitations by regions available on the Government Electronic Tendering System (GETS), by using "Temporary Help Services" as a search criterion and submit bids in accordance with the instructions therein.

The ongoing opportunity for qualification under RFSA EN578-060502/I solicitation is conducted on a cyclical quarterly basis as stated in PART 2 – SUPPLIER INSTRUCTIONS, article 5. Closing date for bid submissions in quarter Q4 is March 31, 2015, 2:00PM Eastern Daylight Time (EDT).
