Addendum 1

QUESTION AND ANSWER

Q1: I noticed that Section 00 21 13, Paragraph 1.7 states that tipping fees are to be included in the pricing sheet. In the past the landfill was charged to the base directly. Is this paragraph correct and if so, does the estimated weight include all waste from the base or just the waste for this contract.

A1: The tippage was paid by the Base directly in the past, but that will not be the case for this contract. As per Section 00 21 13, Paragraph 1.7, tipping fees are to be included in the bidder's price. This new contract encompasses all 3 previous dry garbage contracts into one. With an estimated total of 2461 metric tons of dry garbage, this is an average of the past 4 year's tippage for the entire Base and Training Area.
