QUESTIONS AND ANSWERS

Q1. Is PWGSC able to define specifically the difference between Commercial and Business matters related to facilitated discussion / mediation? If an offeror has expertise in only business matters (workplace) and not commercial (business to business), would that deem them to be non-compliant or could an offeror bid on business only?

A1. The Statement of Work, Stream 4, Part 1, defines conflicts of Commercial or Business nature as mediation services related to business or contract disputes between Government and Industry. Workplace conflicts are not part of Stream 4, Part 1. Resources must show expertise in the Commercial / Business area to be considered responsive.

Q2. Is PWGSC able to share any anticipated volume (estimates only) within both commercial and business matters by region?

A2. Yes. The estimated volume, across Canada, on annual base is \$ 240,000.00. Breakdown by regions is not available.

Q3. 1.1.1 Mandatory Technical Criteria – for MT2, what information does PWGSC require to be outlined for the 7 additional projects since the solicitation is only requiring that three (3) of the projects submitted require the detailed information listed in MT2?

A3. Information required by PWGSC:
Names of the client organization and Project Authority;
Brief description of the Scope and Objective of the project to clearly show relevancy of the project;
Start and end dates of the project (month / year to month / year).

Q4. 5.1 Basis of Payment – Can the PWGSC specify in which scenarios, or clarify when the Contractor must invoice the other half of the costs to the other participant in the facilitated discussion / mediation? Does this apply to all call ups or only select ones?

A4. In every scenarios and all call ups for facilitated discussion / mediation services, the Contractor must invoice the costs equally to both participants.

Q5. Would PWGSC be willing to share the questions and answers from the initial Standing Offer (E60ZG-090005)?

A5. Yes, please refer to PWGSC Buy and Sell website at <https://buyandsell.gc.ca>, choose Services and do a search using E60ZG-090005/D and /E. The Questions and Answers for the previous and current Requests for Standing Offers are included in the amendments of these two resulting Tender Notices.

Q6. Would the median price from the initial Standing Offer (E60ZG-090005) be used in any capacity for this evaluation or would it be a combined median with the current solicitation for financial evaluation?

A6. No. Offerors must complete the pricing schedule for all resources. For this solicitation E60ZG-090005/E, the median will be calculated based on the financial proposals of all technically responsive offers.

Q7. If the majority of proposed resources only have Reliability Status, for APPENDIX 1 to ANNEX A, can an offeror indicate Reliability Status and have the resource updated pending additional screening at a later date? Are there any proportionate estimates of call up volume by security level?

A7. Yes, the offer can state the level of security the resources currently have and update their security later as required. However, we advise all offerors to apply for security upgrades as soon as possible. The process can be long and the resources are unable to work while their clearances are pending.

There are no proportionate estimates of call up volumes by security levels available.
