**REASON FOR AMENDMENT:**

Canada is publishing herein responses to enquiries that it received pertaining to this solicitation subject to Period 2 – Supplementary Question Period as set out in accordance with Article 2.7 - Enquiries - Request for Bids. Please note that Canada may respond to questions in a non-sequential order. Canada is also activating Period 3 – Final Supplementary Question Period.

**Modifications to the RFSO/SA have been made to the French solicitation only. No changes are made to the English solicitation.**

**Questions and Answers:**

**Question 44:**

If there are no changes for our company, do we have to submit a “flash drive” with our hard copy, i.e. I am unclear as to what to put on the flash drive?

**Answer 44:**

A copy on USD or CD is a requirement of the Section 1 Technical Bid as indicated under Part 3 – Bid Preparation Instructions on page 15 of the RFSO/SA (E60ZN-15TSPS/A) and under Part 3 – Arrangement Preparation Instructions on page 15 of the RFSA (E60ZN-15TSSB/A). If you are not changing your Technical response and simply renewing the streams and/or categories for which you are currently qualified, you will submit the Grandfather Certification (Section III Certifications) in print and in the DCC. You are not required to submit a copy on USB or CD.

**Question 45:**

*Although the following question was submitted against the RFSA (E60ZN-15TSSB/A), the response also applies to Question/Answer # 21 in Amendment 003 of the RFSO/SA (E60ZN-15TSPS/A).*

In relation to Question/Answer #18 of Amendment 3, as an existing Solutions SA holder, our agreement currently covers tier 2. As we go to renew, we would also like to be eligible to receive opportunities under tier 1. In order to do so, we understand all this requires is adding tier 1 when we complete the DCC component online.

As such, please confirm we follow column 'C' in the arrangement submission grid and NOT column 'D' since we are adding a lower tier.

**Answer 45:**
