This RFI amendment 4 is to formerly invite Industry to attend one-on-one meetings with the NRWS project team.

#### Industry One-on-One Meetings

Canada is offering up to two (2) one-on-one meetings with each interested supplier, a one (1) hour Technical Meeting, and a one (1) hour Industrial and Technological Benefits (including Value Proposition) meeting.

The purposed of these meetings are to discuss and clarify feedback received on the NRWS draft Request for Proposal that is being released under this Request for Information (RFI) process. Questions and answers raised during all meetings may be documented and released under a future RFI amendment to ensure all suppliers receive the same information.

Participating suppliers will be required to sign an **Engagement Agreement** form which will be provided by the Contracting Authority upon request for a meeting. Confirmation of the meeting(s) will be issued by the Contracting Authority once the Engagement Agreement has been submitted.

One-on-one meetings will be held during the period starting **Monday March 30th 2015 to Friday April 17th 2015** between the hours of 0900h to 1700h eastern daylight Savings time. Due to the Easter holiday in Canada, meetings will not be scheduled on Friday April 3rd 2015, and Monday April 6th 2015. The Contracting Authority will arrange one-on-one meeting dates, times, location and building access requirements directly with each attending supplier on a first come first serve basis.

A maximum of four (4) attendees per supplier will be permitted to attend the meetings. Suppliers who choose to attend should submit a confirmed list of representatives to the PWGSC Contracting Authority no later than **March 27th 2015**, otherwise meetings cannot be guaranteed.
