QUESTIONS AND ANSWERS

Question 4

Can nurses currently providing the requested services to VAC (under contract with the incumbent provider) be able to use this experience under Point Rated Criteria 1, 2, and 3? If not, this would seem to put the incumbent provider at a disadvantage for earning maximum points in these areas. Will VAC therefore consider allowing work under the current VAC contract to be applicable to months of equivalent experience in these three areas?

Answer 4

It is possible that Nurses presently providing these services under an incumbent VAC contract are obtaining the experience being evaluated for all three point rated criteria. All bidders will have to clearly demonstrate how much experience has been obtained for each criterion in accordance with the instructions outlined in the RFP document.

Question 5

Can you please clarify if the point rated criteria are only applicable to the primary resource or if it is also applicable to nurses presented as back up personnel?

Answer 5

The mandatory criteria are applicable to both the primary resource and the back-up / replacement resource. The point rated criteria are only applicable to the primary resource.

Question 6

If a proponent wishes to bid on all three regions, should we submit 3 separate proposals? Or is it acceptable to submit 1 proposal (while clearly defining the nurses by region) and submit all three price forms together in Section II: Financial Bid?
