A1. Environmental Scientist minimum education level remains unchanged. PM level has been changed - please refer to Amendment 003 below.

Q2. Referencing p. 47/64 of the RFP: Part 1 Technical Evaluation, Section 3.0 (Technical Requirements – Mandatory and Point Rated Criteria), Sub-section 3.2 (Mandatory Criteria – Corporate Criteria), is a CADD company (as opposed to an individual) permitted to be provided?
