  - 3.4.14 Project Management Services
    - .1 Provide project management service for the construction contract at the request of PCA.
    - .2 When requested to do so, provide all services to manage the contract on behalf of PCA, taking on the role of project manager and all activities associated with that role, through the life of the construction stage of the project.
