THIS AMENDMENT #006 IS RAISED TO CLOSE PERIOD 3 – FINAL SUPPLEMENTARY QUESTION PERIOD.

PWGSC will not extend the closing date of the RFSO/SA (E60ZN-15TSPS/A). This solicitation has been posted on BuyandSell.gc.ca since February 9th, 2015 (Reference number: [PW-\\$\\$ZN-003-28441](#)). PWGSC has operational requirements to complete all bid evaluations prior to the current expiry date of the existing arrangements and standing offers. In light that non-substantial material changes have been made, the closing date of the RFSO/SA as referenced on the front page of the solicitation will remain unchanged and is scheduled to close on March 23, 2015 at 14:00 EDT.

Suppliers will have the opportunity to become pre-qualified for the Supply Arrangement Tasks portion only in accordance with the Quarterly Refresh Cycle as outlined in Article 6.4.2, the first of which is anticipated to be published in June 2015. Suppliers are encouraged to visit the [Centralized Professional Services e-Portal](#) and review the information under “For Businesses” and reviewing periodically by clicking on the [Supplier Dashboard Snapshot](#) to review updates as to the anticipated solicitations.

Suppliers are reminded of the following:

- TSPS active solicitations will be published on Buyandsell.gc.ca at which time will simultaneously become active for bid data entry on the CPSS Solicitation Dashboard at: [Centralized Professional Services ePortal](#); and
- There will be no opportunity on a quarterly basis to qualify for the TSPS Standing Offer(s).

Closure of Period 3 – Final Supplemental Question Period:

Canada hereby confirms that Period 3 – Final Supplementary Question Period (March 10, 2015 at 14:00 EDT) is now closed. Questions received during this period will be answered in Amendment 007 which will be published shortly.

REMINDER:

TSPS Bidders are reminded that they can finalize their TSPS bid and submit in DCC before the closing date of the TSPS bid solicitation. In the event that TSPS bidders have a requirement to modify their TSPS bids, the DCC will allow them to amend their TSPS bids and resubmit up until the bid closing date and time as shown on page 1 of the solicitation. The resubmitted bid in the DCC will supersede all other bids previously submitted.
