This amendment 001 to the request for proposal is to answer questions from the industry.

QUESTION 1

Considering that the firm that developed the referenced approach will most likely act as an image reseller to provide purchase prices to other bidders and that it will likely be a bidder for this project, how can we have the assurance that the prices offered by the image reseller will be impartial and equivalent to its own acquisition costs?

ANSWER 1

Bidders are free to use the image reseller of their choice. For your information, there are more than one resellers for these images.

QUESTION 2

On page 20, section 2.4, it is mentioned that the mapping products must be delivered during the 48 hours following each acquisition. Is it 48 calendar hours or 48 working hours? If it is calendar hours, are weekends counted?

ANSWER 2

For the purposes of the demonstration test, weekends and holidays will not be counted within the 48hrs.
