THIS AMENDMENT #007 IS RAISED TO ANSWER QUESTIONS RECEIVED.

REASON FOR AMENDMENT:

Canada is publishing herein responses to enquiries that it received pertaining to this solicitation subject to Period 3 – Final Supplementary Question Period as set out in accordance with Article 2.7 - Enquiries - Request for Bids. Please note that Canada may respond to questions in a non-sequential order.

Questions and Answers:

Question 46:

Due to the complexity of the solicitation would PWGSC consider granting bidders an extension?

Answer 46:

Please refer to Amendment 006 to the RFSO/SA (E60ZN-15TSPS/A).

Question 47:

The categories we seem to have been granted in Tier 2 are less in number than those categories we hold in the SO and Tier 1. If we want to add other categories to Tier 2 that we already hold and have substantiated in the SO and Tier 1, what is required?

Answer 47:

Although Suppliers who meet the Mandatory Criteria of Tier 2 will be considered to have met the Mandatory Criteria of Tier 1 if they have indicated in the DCC that they wish to provide both Tiers, as per Article 4.2 Basis of Selection in Part 4 of the RFSO/SA (E60ZN-15TSPS/A) an Article 4.2 Basis of Selection in Part 4 of the RFSO/SA (E60ZN-15TSSB/A), the reverse is not applicable. That is, Suppliers who meet the Mandatory Criteria of Tier 1 are not considered to have met Tier 2. They must submit substantiation through project summaries and references in accordance with Attachment B of the RFSO/SA and RFSO/SA. They must also indicate in the DCC that they wish to provide both Tiers.

Question 48:

Section 6.4.2 indicates that we will have the option to make changes to our arrangement at one of three Refresh periods during the year. In addition to making changes to Streams, would we be able to make changes to our Tier level? For example, if we currently qualify for Tier 1 and submit Grandfather Certification and DCC submissions, can we qualify for Tier 2 during the Refresh period?

Answer 48:

Suppliers may make changes to their arrangements at either the renewal solicitation or at the subsequent refresh solicitations. The Grandfather Certification submitted at the renewal solicitation allows Suppliers to renew their existing streams and categories without further substantiation. Any categories or streams for which Suppliers are not qualified will have to be substantiated in accordance with Attachment B of the RFSO/SA (E60ZN-15TSPS/A) and Attachment B of the RFSO/SA (E60ZN-15TSSB/A). For Tier 1 SA holders who now wish to become Tier 2 holders, please refer to the answer to Question 47.

Suppliers are also referred to the response to Question 35 in Amendment 003 of the RFSO/SA (E60ZN-15TSPS/A) and Question 26 in Amendment 003 of the RFSA (E60ZN-15TSSB/A) which states:

As per Part 6A, Article 6.4.2 Request for Supply Arrangement (RFSA) Bid Solicitations on page 29 of the RFSO/SA (E60ZN-15TSPS/A) and Part 6A, Article 6.4.2 Request for Supply Arrangement (RFSA) Solicitations on page 30 of the RFSA (E60ZN-15TSSB/A), the Supplier will not be eligible to submit a submission in a particular Refresh Period if they have submitted in the previous Refresh Period because their profile will be disabled in the DCC while the submission is being evaluated. Data entry into the DCC is a mandatory requirement of any refresh solicitation. If the Supplier's profile is disabled, the Supplier cannot enter into the DCC and therefore, is not able to fulfill the mandatory requirement for the next refresh solicitation. For example, if a Supplier submits in Refresh Period 1, their profile will be disabled in the DCC while their submission is being evaluated. The Supplier will not be able to submit for Refresh Period 2 but will be able to submit for Refresh Period 3.

Question 49:

We previously held a TSPS SO/SA for a Joint Venture but, due to a reporting oversight, we no longer hold this. Is it possible to renew this previous submission, or do we submit as a new bidder?

Answer 49:

As per Part 6A Article 6.3.2 Supply Arrangement Reporting (page 28) and Part 7A, Article 7.3.2 Standing Offer Reporting (page 42) of the RFSO/SA (E60ZN-15TSPS/A) and Part 6A Article 6.3.2 Supply Arrangement Reporting (page 29) of the RFSA (E60ZN-15TSSB/A), PWGSC may suspend the Standing Offer (SO) or Supply Arrangement (SA) without notice, if reports are not submitted on time or are inaccurate or incomplete. If the SO and/or SA is suspended, it is set to "inactive" until such time as the reporting requirements are met. Pre-qualified SO and SA holders are reminded of this in the reporting notification that is sent on a quarterly basis by the TSPS Authority. The suspension prevents pre-qualified SO and SA holders from appearing in the search results and from bidding on Client requirements until they fulfill the requirements for reporting and their SO and SA are set back to "active".

Suppliers whose SO and/or SA have been suspended as a result of a failure to meet the reporting requirements may submit the Grandfather Certification for the renewal solicitations (E60ZN-15TSPS/A and E60ZN-15TSSB/A) in order to continue to hold the categories and streams for which they are currently qualified.

1. Suppliers who were awarded a SA and/or SO under solicitation E60ZN-13TSPS/B, E60ZN-13TSPS/C, E60ZN-13TSSB/B and/or E60ZN-13TSSB/C under PBN XYZ will be able to complete the DCC and submit through grandfathering for the categories and streams for which they are currently qualified. Please refer to Column C and D of the Bid Submission Grid at Part 3, Article 3.1.3 found on page 17 of the RFSO/SA (E60ZN-15TSPS/A) and Column C and D of the Arrangement Submission Grid at Part 3, Article 3.1.3 found on page 17 of the RFSA (E60ZN-15TSSB/A).
2. Suppliers who were awarded a SA and/or SO under a solicitation prior to 2013 under PBN XYZ and did not renew against solicitation E60ZN-13TSPS/B, E60ZN-13TSPS/C, E60ZN-13TSSB/B and/or E60ZN-13TSSB/C for the purposes of grandfathering are required to submit as a new supplier. Please refer to Column B of the Bid Submission Grid at Part 3, Article 3.1.3 found on page 17 of the RFSO/SA (E60ZN-15TSPS/A) and Column B of the Arrangement Submission Grid at Part 3, Article 3.1.3 found on page 17 of the RFSA (E60ZN-15TSSB/A).

The current SO and/or SA and any newly awarded SO and/or SA in response to solicitation E60ZN-15TSPS/A and/or E60ZN-15TSSB/A will remain inactive until such time as the reporting requirements are met.

Question 50:

We were originally grandfathered on the last TSPS Task based RFP. We are hoping to prequalify on more categories. In this instance, since we did not submit project summaries (due to the grandfathering), do we need to submit project summaries for the new categories or would references suffice.

Answer 50:

Please refer to the examples provided on page 2 of 23 in Attachment B and on page 2 of 19 in Attachment C of the RFSO/SA (E60ZN-15TSPS/A) and on page 2 of 14 in Attachment B of the RFSA (E60ZN-15TSSB/A) with regards to existing SA and/or SO holders looking to add categories and/or streams to their SA and/or SO.

Question 51:

Can the Crown extend the bid Closing date by three weeks as the Crown has released many of their large refreshes at the same time, ie. TSPS Solutions, TSPS Task, TBIPS and PASS was just submitted.

Answer 51:

Please refer to Amendment 006 to the RFSO/SA (E60ZN-15TSPS/A).
