A. Questions and Answers

- Q1. I am not seeing in here that we have to quote Domtar/ Weyerhauser/ Xerox paper, only specs. Are we able to shift our quote to our house brand? Have we missed something in the RFP?
- A2. CRA is <u>not</u> requesting that a specific brand of paper be proposed, as this is a competitive solicitation. The requirement is that the paper proposed by a Bidder must meet the specifications outlined in Annex A: Statement of Work to be considered successful; therefore you can quote a house brand if it will meet <u>all</u> of the specifications for paper.
- Q2. Under PART 7 MODEL CONTRACT of the RFP, section 7.9
 PACKAGING AND SHIPPING states the following: "All packaging material is to be removed from the site by the Contractor for reuse, recycling, or be disposed of in an environmentally preferable manner."

The removal of packaging materials is not an industry standard. The boxes of paper will be dropped off unpacked at the various locations by either our own drivers or by third party couriers. Our trucks and those of third party contractors are not equipped to handle loose packaging, and in fact this could become a work hazard for our drivers. Most government building do offer recycling services so any packaging resulting from the opening of the paper from their packaging by end users should end up in the building's recycling bins. Would CRA consider dropping this requirement for the removal of all packaging material by the Contractor?

A2. CRA will remove this requirement from the RFP as it will not be required for this type of commodity. Please refer to Amendment #2 to the RFP below.
