This solicitation amendment 001 is raised to:

- 1. Respond to Bidder's questions pertaining to the Request for Proposal EN891-151438/B; and**
- 2. Amend Part 7, Resulting Contract Clauses, Article 5.1 Basis of Payment.**

1. Questions and Answers:

Question 1: Section 2.1.3.1 - Other Service-Cash Order Pickups: Are we able to respond to this section only?

Answer 1: Yes, you are able to respond to this section only. However, as stated in the Annex A – Statement of Work, Canada maintains sole discretion as to whether, and for which departmental office locations, this other service will be implemented.

Question 2: Please confirm this contract will only apply to Canadian cash orders.

Answer 2: The cash order services described in the Statement of Work are primarily for Canadian dollar denominated cash orders. In some rare situations it may occur that US dollar cash orders are requested, but servicing these cash orders would be at the availability/discretion of the financial institution location servicing the requesting departmental office.

Question 3: Please provide Part 2 pages 6 to 8 Bidder Instructions in a Microsoft Word format document.

Answer 3: Please note that Part 2 pages 6 to 8 of the RFP may be provided by e-mail in Microsoft Word format upon written request to the Contracting Authority.

Question 4: Please provide Attachment 1 to Part 3 pages 11 to 18 Pricing Schedule in a Microsoft Word format document.

Question 5: Please provide Part 5- Certifications page 21 and Attachment 1 to Part 5 page 22 in a Microsoft Word format document.

Answer 5: Please note that Part 5 – Certifications on page 21 and Attachment 1 to Part 5 on page 22, may be provided by e-mail in Microsoft Word format upon written request to the Contracting Authority.

Question 6: We are requesting the volumes (# of orders) of cash orders, represented by the value statistics provided for each department. That is, how many Cash Orders were placed by these departments?

Answer 6: As cash orders were charged under the existing contract based upon the value of the cash order processed and not the volumes; no reliable historical cash order volume statistics are available to be provided.

Question 7: The Armoured Car Carriers (ACC) the Departments will use, for the Optional Large Cash Order service. We restrict access to our currency operations centres, to ACC companies that meet our internal security and control requirements. Ergo, not all ACC's are allowed to enter our premises.

Answer 7: Understood. Should Canada decide to implement this Other Service for Cash Order Pickups; armoured car carrier restrictions would be discussed at that time.

2. Amend Part 7, Article 5.1 Basis of Payment:

DELETE:

5.1.1 Firm Lot Price

For the Work described in Annex A of the Statement:

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid a firm lot price of \$_____. Customs duties are included and Applicable Taxes are extra.

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.

INSERT:

5.1.1 Firm Unit Price

For the Work described in Annex A of the Statement:

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid the firm unit price indicated in Annex B, Basis of Payment. Customs duties are included and Applicable Taxes are extra.

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.
