Q1. Is it possible to attend the Bidder's Conference by phone or must it be in person?

A1. You may call in to attend the Bidder's Conference via teleconference. Once you register for the Bidder's Conference indicating you wish to attend by phone, a conference number will be provided.

Q2. When will you be able to provide usage item estimates for the line items on the spreadsheet?

A2. A revised spreadsheet will be available for download the week of March 23rd. This version will also include enhanced line item descriptions. If you require further clarity on line item descriptions after the new spreadsheet version, you can contact the Standing Offer Authority for further clarifications.

Q3. What measurements are you using to award the Standing Offer? By location or by item?

A3. The standing offers will be awarded based on item by line item approach.

Q4. What happens if our bid is higher because we bid on more line items? Is this being considered?

A5. The awards are based on a line by line item basis. However, the standing offers will be issued to those vendors who have the highest percentage of low line items per category. If you have only one line item as the lowest line item in a category, you would not likely be issued a standing offer. We would then go to one of the other bidders within the category to further assess their prices per that specific line item. Logistic and business rules will also be applied during the evaluations.

Q6. Will our bid still be considered if we are not able to quote on each item requested?

A6. You are not required to bid on each item in any one category, the standing offers will be awarded to those firms with the highest number of low bid items in each category.

Q7. I have questions about the descriptions of some of the line items, how can I get clarification?

A7. Version 2 of the spreadsheet will contain enhanced descriptions. If further clarifications are required on specific line items, you can contact the Standing Offer Authority once you have reviewed the new spreadsheet.
