QUESTION AND ANSWERS SERIES I:

Q1:

I have read the new RFP and I have a question regarding the criteria in general when they are asking about frequency.

When it says :

Number of days per week devoted to the conduct of occupational health assessments (converted to full time equivalent)

Do you need that measurement for each employment of the resource?

Like this :

CV :

1st employment : days/weeks and converted days/months

2nd employment :

3rd employment :

Or do you need the total amount of occupational health experience acquired during past 10 years?

A1:

To clarify our requirement: "within the last 10 years" means that any work experience being described must be recent; i.e, occurring in the last 10 years only.

-When referencing the relevant experience required by the evaluation criterion: "Number of days per week (converted to full-time equivalent)" means: number of days/week spent "doing" the required experience, converted to total number of months.

For example, 2 days/week spent conducting occupational health assessments in one workplace, would be converted to 8 days/month, which would be multiplied by the total number of months spent doing this activity in this workplace.

If the professional resource has accumulated the same experience in other workplaces, the same calculations would be done to arrive at a total number of months doing the relevant experience.
