QUESTION 4

In section 3.0, page 21 it is stated that the color maps format A0 with SM concentrations measured at sea are requested for each satellite images. Must these maps be provided in paper format. If so, should they be provided in five printed copies, for both the interim report and the final report?

ANSWER 4

Yes, the maps must be provided in paper format for the final and the interim report. A0 is mentioned as an example of large format, A1 and B1 formats are also accepted.

QUESTION 5

As part of the deliverable 3, page 20, it says that plans must be delivered in AutoCAD format for the progress report. But, there is no question of such plans in the statement of work, in section 1.1 on the calibration of multi-spectral bands, or in Section 1.2 of the introduction and application of MES model. Are we talking about A0 maps? If so, are that these plans required to be produced and delivered in AutoCAD for deliverable 3?

ANSWER 5

The maps can be generated in Autocad or ArcGIS format.

QUESTION 6

During the deliverable 5 and 6 pages 20-21, it is mentioned that the bidder must produce a PowerPoint presentation in electronic format. It is not mentioned if it is to be presented as part of a final feedback meeting or simply be delivered at the end of the project. Can you please clarify?

ANSWER 6

The presentation should simply be supplied with the report.
