AMENDMENT 004

The purpose of this amendment is to:
-Advise Bidders of questions and answers;

Question 17

Point 7.1.2.2.4 states that the contractor must not commence work until a task authorization (TA) has been received. Point 7.1.2.3 states that the Project Authority must authorize a TA in excess of \$5,000. Are we talking about two different task authorizations?

Answer 17

No, it is the same task authorization. The contractor must not commence work before receiving the TA, whether it is in excess of \$5,000 or not.

Question 18

Point 7.1.2.6 states that data on the services provided must be submitted on a quarterly basis to the Contracting Authority based on quarterly periods. Is providing these data a mandatory requirement?

Answer 18

Providing these data is a condition of the contract.

Question 19

Point 7.3.1 states that the Contractor/Offeror must, at all times, hold a clearance at the PROTECTED B level. In point 2 below, it states that the Contractor's personnel must hold RELIABILITY STATUS. Are these two different security ratings?

Answer 19

No. Reliability Status is needed to handle PROTECTED B documents. The bidder must ensure to meet all security requirements as indicated in Part 6 – Security, Financial and Other Requirements, 6.1 Security Requirements:

Question 20

Regarding the security requirements, in point 2.1 (page 46 of 52), does a CISD Field Industrial Security Officer do a bi-annual inspection of the premises of all StatCan contractors or only the premises of contractors who handle sensitive information (protected A, B, C)?

Answer 20

For the purposes of this request for proposal, the CISD will, twice a year, inspect the premises of all contractors who will be awarded a contract.
