This amendment is raised to answer questions from suppliers.

Q1: I do not see any particular grade of fabric requested in this tender. Typically each manufacturer has slight variances in their Grade A vs. another's Grade A or Grade 1 as the case may be. As it is a tender our best price is for the lowest grade, is this acceptable as I believe all bidder's will do the same. Our least expensive grade does have multiple color options. Please advise

Q1A: The answer regarding fabrics seems to be too wide open for interpretation. The product I will likely bid has 10 available fabrics, whereas some manufacturers will have only 3 to 4 available fabrics and their medium fabric would never be equivalent to our medium fabric. This can make the difference in the bid .The table below shows the "list price difference ". Leather products vary in quality. Although we have 4 different grades of leather, the higher priced ones are not necessarily stronger, in fact they are more expensive because they are softer than the grade 1. Grade I leather is the choice 95% of the time. When asked previously for medium grade fabrics, we have typically gone to a grade 2 at most, our selection is quite varied.

If I may suggest, it may work better for all bidders to be asked for their entry level fabric and 1st grade of genuine leather (not faux leather) and let the client decide at award whether they want to upgrade to something higher than the entry level grade of both fabric and leather.

Q2: Are we quoting these chairs COM. In the document it mentions black leather and fabrics but it is not clear.
