All responsive suppliers will be issued a Supply Arrangement (SA) and will become a qualified supplier under the Supply Arrangement. The published Rates listed under the SA represent the maximum Rates that the qualified supplier will be allowed to propose for any bid solicitation under the Supply Arrangement. Qualified suppliers may submit unit rates lower than their Published Rates during the bid solicitation stage.

Suppliers are to identify what regions they are wishing to qualify for. Duplicate rates are to be provided if they differ for various areas.

All other Terms and Conditions remain unchanged
