Solicitation Amendment No. **001**

This solicitation is hereby amended to provide the following questions and answers:

Q1. Who was awarded the existing standing offer and how much (in dollars) did they receive in the last two years for these services?

A1. The existing standing offer agreement (W0105-13E060/001/MCT) was issued to Royal Environmental Inc., operating as Ready John Environmental Services, RayTek Environmental Solutions, on August 12, 2013 in the amount of \$2,034,000.00. As to how much (in dollars) the Contractor received in the last two years, that information would have to be requested from Department of National Defence through the Access to Information office.

Q2. What kind of toilets are barrier free toilets? Are these handicapped units?

A2. Yes, these are handicapped units as described in Section 1.7.2, Chemical Toilets, of Annex A.

Q3. Is the 75 hand wash toilets quantity included with the 800 regular toilets or is it an extra 75?

A3. No, these are accounted as separate units from the standard toilets.

Q4. Is it possible to know if the dumping of the waste is done in Petersville Lagoon, and is there a charge for the dumping that the contractor will be responsible for?

A4. Yes, the Petersville Lagoon is available to dump waste; it is monitored as described in Section 1.13.3 of Annex A. No there is no charge to use the Petersville Lagoon for all waste removed in accordance with this standing offer.
