Question 23

Because of the time needed to obtain the required security rating for documents, will the Contracting Authority delay awarding contracts to the successful bidders who have not yet received the rating? If not, can you extend the deadline for submitting bids?

Answer 23

A decision on the date to award contracts will be made once the bids have been evaluated.

The deadline for submitting bids will not be extended.

Question 24

I do not have the security clearance required in Part 6 of the request for proposals, neither for myself nor my location of work. Is it worth preparing a bid or will it be rejected right away? In other words, is it possible to submit a bid and receive the required clearance after the bid closing date? My question is based on Section 6.1.1 a), which stipulates that "Before award of a contract, the following conditions must be met:", and on Section 6.2, which states that "any delay in the award of a contract to allow the successful bidder to obtain the required clearance will be at the entire discretion of the Contracting Authority." This implies that a bidder can be successful even if he/she does not meet the security requirements and can receive the necessary clearance after the fact. Can you confirm this? Thank you in advance.
