Solicitation Amendment No. 001 is being issued to address the following:

A) Amend Part 4, Section 1.2, Subsection 1.2.1 - Mandatory Financial Criteria

B) Amend Annex "B" - Basis of Payment, Section 2.0 - Optional Quantities

C) Questions and Answers

A) At Part 4, Section 1.2, Subsection 1.2.1 - Mandatory Financial Criteria

Delete in its entirety;

Insert:

The bidder must complete, in accordance with Annex "B" - Basis of Payment, Section 1.0 and Section 2.0 in Canadian funds, applicable Taxes excluded, FOB destination, transportation included, Canadian customs duties and excise taxes included. Pricing must be provided for all firm and optional requirements.

Bids will be evaluated based on the prices detailed in Annex "B" - Basis of Payment.

B) At Annex "B" - Basis of Payment, Section 2.0 - Optional Quantities

Insert: Environment Canada will commit to a minimum order size of 50 sensors for each optional quantities order.

C) Questions and Answers

Q1: At Annex "F" Evaluation Criteria, PART A - Mandatory Technical Criteria, Item 4.3.1 Test Data

Does this mean that at each measurement point there shall be 5 parallel (repeating) measurements ?

A1: For each sensor (two separate sensor units must be tested - see section 4.5), at each test point, the testing system must repeat the reading five times. These five sequential readings must be at least one minute apart, using the same testing equipment.

Q2: At Annex "F" Evaluation Criteria, PART A - Mandatory Technical Criteria Item 4.2 Facility Accreditation, item a)

a) the reference RH Sensor in the test chamber must have current and valid accreditation to ISO 17025:2005 (or later) to the expanded uncertainty of $\pm 1\%RH$, or better, for humidity at the 95% level of confidence with a coverage factor of 2; and

Question:

Does this mean that complete RH measurement must have current and valid accreditation to ISO 17025:2005 (or later) to the expanded uncertainty of $\pm 1\%RH$, or better, for humidity at the 95% level of confidence with a coverage factor of 2 ?

A2: On Item 4.2 Facility Accreditation, our intention is that the test chamber (facility/lab) can provide measurements of RH (and temperature) to the specified level of accuracy. ISO accreditation for which we are asking applies to the whole lab (as a business) that can produce measurements of a parameter to a stated accuracy, and therefore falls under the business of gaining the ISO certification.

Q3: Could you please tell me if you already have a Digital or Analog Readout for this item? Or will one need to be purchased as well ?

A3: The Relative Humidity Sensors will be read using an existing automated data collection system that can read either the digital or analog output specified in section 3.6 of the solicitation. No other readout or display is required. The purchase of the data collection system is not included in this solicitation.

Q4: At PART 6 - Resulting Contract Clauses, Section 3.2 - Delivery Date: The amount of sensors yearly requirement is well stipulated for year 1, 2 and 3 but what batch sizes will Environment Canada commit to per year? And / or releases 1 or 2 per year?

A4: For year 1, Environment Canada requires two batches, as stipulated in Part 6, Section 3.2 Delivery Date, for firm quantities. For optional quantities, Environment Canada will commit to a minimum order size of 35 sensors (i.e., zero to two batches).

For years 2 to 3, Environment Canada will commit to a single order size of 70 sensors for fixed quantities (i.e., one batch), and a minimum order size of 35 sensors for optional quantities (i.e., zero to two batches).

For years 3-10, Environment Canada will commit to a minimum order size of 50 sensors for optional quantities (i.e., zero to two batches).

Q5. Could you please provide clarification for solicitation # K3D33-121413/B - Relative Humidity Sensors.

Sections 2 and 3 (see below) of the solicitation document indicate different contract award dates, one for 2015 and one for 2016. Which table is correct?

2018. If the optional quantities are exercised, the optional quantities must be delivered within
