QUESTIONS AND ANSWERS

Question No. 1

The RFP requires that vendors propose an entity perpetual software license. The RFP also states that CBSA is the initial client of the proposed solution and that Canada may make the solution available to other departments and agencies for which PWGSC is authorized to act under section 16 of the Department of Public Works and Government Services Act. We have several concerns with the entity license requirement as it relates to the RFP:

- 1) An entity license penalizes the Crown by burdening licensing costs up front, while the benefit of the project will be gradually realized over a number of years. The Crown will be paying for software that may not be deployed for years. -Any vendor that bids will propose unnecessarily high licensing costs to account for the "entity" being licensed in order to mitigate potential lost revenue based on an uncertain, uncapped license requirement.
- 2) Many vendors will not bid because of the entity license requirement as they either cannot accept this type of license agreement or may feel their bid will artificially impact the pricing landscape of the marketplace. This will impact the number and the quality of bids received.
- 3) The Crown is reserving the right to make this solution available to other departments which brings into question the value of the entity license. How can vendors responsibly set an entity license price for Canada for a solution with such an unknown deployment pattern? This is not fair for the Crown, for the vendor community or the tax payers of Canada.

We recommend that the Crown reconsider its requirement for an entity license for the reasons stated above. We also recommend that the Crown changes the requirement to a perpetual terabyte license. Terabyte licensing provides the following advantages:

- 1) Pay based on the size of the data source being managed, not for unused capacity or the infrastructure the solution is running on
- 2) Buy what you need when you need it.
- 3) Provides pricing scalability, not one size fits all.
- 4) Terabyte pricing allows customers to exploit new hardware innovations and processor technologies without impacting software licensing costs as is the case with processor based licenses.

- 5) Specifically with the Government of Canada and SSC managing the hardware, a usage based pricing model will protect against departments being surprised by an increase in licensing costs due to hardware decisions made by SSC.

The Software Solution must deliver and provide functionality to age test data according to CBSA's parameters.

Question No. 4

At Annex A, Section 2 - Mandatory Requirements, Table A - Technical Requirements, NO # A22:

The Software Solution must refresh the test data from either an extract file or do a partial refresh from the source.

Question: Please clarify what is meant by "do a partial refresh from the source". Could it mean extracting data from the source to create a new extract file to refresh the test data?

Question No. 5

At Annex A, Section 4 – Solution Rated Requirements, Table F - Rated Requirements, NO # F1:

The Software Solution should be able to substitute Binary Large Object (BLOB) files with generic BLOB files.

Question: Are these BLOBs stored in database BLOB columns or binary files in the directory referenced from the database?

Question No. 6

At Annex A, Section 4 – Solution Rated Requirements, Table F - Rated Requirements, NO # F8:

The Software Solution should accommodate backup to Tivoli Storage Manager (TSM).

Question: Does the “backup” refer to the metadata of the solution or the extract files created?

Reference 7.4(b)(i) and 7.15(b)(i) -- Please confirm that the stated version (2010-08-16) is in fact the latest version of Supplemental General Conditions 4003.
