ITEM No.1: Refer to Section 08 71 00.02. Revise the following:

D403: Revise Door Type from 'A' to 'C'

D410B: Revise Door Type from 'B' to 'C' and Frame Type from 'B' to 'A'

ITEM No.1: Refer to Drawing 1/A1.2. Delete note 28 in room 706 and 707.

ITEM No.2: Refer to Drawing 2/A1.2. Delete note 29 in room 401 and 430.

ITEM No.3: Refer to Drawing 2/A2.2. Delete Room No. 141 tag near GridLine 1 and Z2.

ITEM No.4: Refer to Drawing 2/A2.2. Delete note 2 near GridLine X1 and Z1.

ITEM No.5: Refer to Drawing 2/A2.2. Delete note 1 in room 414.

ITEM No.6: Refer to Drawing 2/A3.2. Add PT2 to wall finish line on the corridor side of room 443 and 433.

ITEM No.7: Refer to Drawing 2/A3.2. Revise PT4 in Room 414 from 'PT4' to 'Colour to be selected by Consultant'.

ITEM No.8: Refer to Drawing 7/A4.1. Revise lowest keynote to 'P. LAM FINISH L1' in lieu of 'P. LAM FINISH L3'

ITEM No.9: Refer to Drawing 8/A4.1. Add note: 'PROVIDE FINISHED EDGE ALONG CUT OUT MILLWORK FOR SURFACE MOUNTED ELECTRICAL CONDUIT. LAMINATE TO MATCH ADJACENT LAMINATE'

ITEM No.10: Refer to Drawing 1/A4.2. Revise dimensions of the overall millwork to the following:

1000 in lieu of 1200 for the depth of the desk;
1400 in lieu of 1200 for the length of the side millwork;
(Note: overall length to remain at 2400)

ITEM No.11: Refer to attached RD 01 for typical slip joint detail for all new walls that go to u/s of floor structure above.

ELECTRICAL

1. Drawing EP2.1:

- a. Refer to 4th floor, RM#406, Finger print room:
 - i. Voice/Data outlet shall be located on east side of the desk.
- b. Refer to 4th floor, open work area #427, student workstations along gridlines #5 and 6 :
 - i. Delete note 10. Power and data to be fed through furniture power pole like rest of the workstations. Furniture power pole shall be provided by furniture system supplier.
- c. Refer to 7th floor, collaborative space area #703, printer station:
 - i. Add standard 15A dedicated receptacle beside the printer receptacle. Wire and connect to available circuit in panel with a 15A/1P dedicated breaker.

2. Drawing ES2.1:

- a. Refer to 4th floor, RM#414, Multipurpose room:
 - i. Revise key note 12 as follows:
 - "PROVIDE NEW WALL MOUNTED PANIC BUTTON. BUTTON SHALL BE RE-MUSHROOM STYLE WITH EMERGENCY LETTERING AND LATCHING CONTACTS."
- b. Refer to 7th floor, open work area #705, between gridline #2 and 3:
 - i. Replace key note 6 for strobe light with key note 5. Strobe light shall be existing ceiling mounted strobe light relocated from 25 forks location.

MECHANICAL

3. Drawing M1.3:

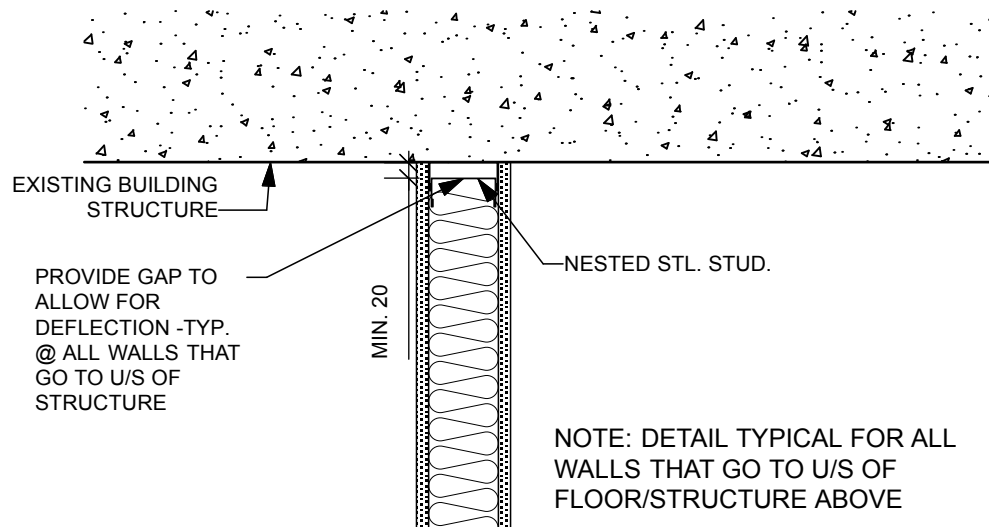
- a. Thermostats located along gridline B between 4 and 7 to be located on the west face of the column to avoid furniture interference.

- b. All thermostat locations to be coordinated with the general contractor to ensure no interference with furniture.

4. General Information

- a. Existing building contains copper sprinkler pipe. All new sprinkler pipes to be made of copper.
