Extension of Time:

Bids previously scheduled to close on 17 April 2015 at 2:00 pm NDT will now close on 24 April 2015 at 2:00 pm NDT.

Site Visit:

Arrangements have been made for an optional site visit to be held on Friday, April 17, 2015. The visit will begin at 2:00 p.m. NDT from the main lobby of the Canadian Coast Guard (CCG) Building on Southside Road. All attendees will be required to register and sign-in with the security desk. A photo ID will be required for entry into the building.

Bidders are requested to communicate with the Contracting Authority at (709) 772-8192 no later than Thursday, April 16, 2015 at 12:00 p.m. NDT to confirm attendance. Bidders will be required to provide the name(s) of the person(s) who will attend and they may be requested to sign an attendance sheet. Attendees are required to provide their own Personal Protective Equipment (PPE), including hard hat, steel toe boots, and reflective vest.

Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.
