The certifications listed below should be completed and submitted with the offer, but may be submitted afterwards. If any of these required certifications is not completed and submitted as requested, the Standing Offer Authority will inform the Offeror of a time frame within which to provide the information. Failure to comply with the request of the Standing Offer Authority and to provide the certifications within the time frame provided will render the offer non-responsive.

In part M1 of Amendment 6 you mention

#### **M1**

The Offeror must obtain their qualification number under CGSB Standard CAN/CGSC-53.148-2011 (Offeror must enter their Qualification Number) for the following class 2 cartridges with their bid.

Which one of the two applies ?

**A1.** The Offerors must obtain their CGSB qualification number prior to issuance of standing offer. The Standing Offer Authority will inform the Offeror of a time frame within which to provide the information. In order to allow CGSB sufficient time to test and qualify the applicable remanufactured toner cartridges, new applications for qualification for the RFSO will not be accepted, if submitted within fifteen (15) calendar days before RFSO closing date.
