# PWGSC's Role

- PWGSC is “*Serving Government, Serving Canadians*”
- PWGSC Acquisitions
- For the purposes of this procurement, Canada is acting as AGENT for the British Army Training Unit Suffield (BATUS)
- Tri-Cities Acquisitions Team (Calgary, Regina, Saskatoon)



# Requirement

- BATUS (British Army Training Unit Suffield) Adventurous Training Centre Canada (BATC Canada)
- New Contract April 1, 2017
- Anticipated duration of 5 -15 years (tbd)
- Estimated Value \$20-25M
- Plus Adventure Training / Challenge Pursuit activities estimated at \$10M

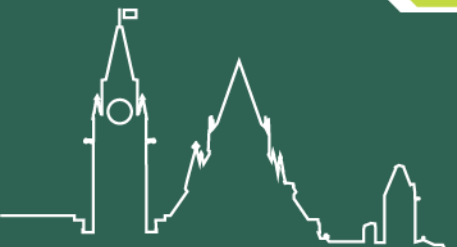




# Procurement Schedule (est.)

- Are contractors willing to work alongside military training instructors in order to maintain an army level of instruction and increase Value Based Leadership?

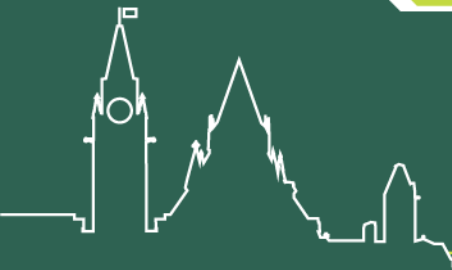


# Questions Cont'd
