We care about your safety while working on the Giant Mine site. The following document has been prepared by Deton'Cho Nuna Logistics Joint Venture (DTNJV) as part of their duties to Public Works and Government Services Canada (PWGSC) to provide Care and Maintenance, Mine Management, Site Safety, and Environmental Protection on site. This document outlines the conditions which all contractors and visitors are subject to including site rules, PPE, vehicle requirements, work permits and documentation. Please note that this document is subject to change so please contact your contract administrator for the latest version prior to conducting any work on site. For a complete list of Safe Work Procedures contact the DCNJV safety department at (867) 445-2884

Site Facilities

Standard Business Hours are Monday – Friday, 7:15 am to 3:15 pm
Security is present on site 7 days per week, 24 hours per day
A First Aid Station is provided at the C-Dry and staffed in accordance with project needs
An Environmental officer will be on site during standard business hours
A Safety Officer will be on site during standard business hours and as required for permitting
Shower and lunch room facilities are available at the C-Dry subject to contract conditions

Site Rules

All Visitors must immediately sign in and complete visitor orientation at the C-Dry building
All Workers must sign in and complete contractor orientation prior to working on site
All work must be in compliance with the NWT Mine Safety Act, the NWT Employment Standards Act, the Occupational Health and Safety Act, the NWT Workers Compensation Act and all Authorities having Jurisdiction over the Job Site
Seat Belts must be worn at all times
Wheel Chocks are to be utilized whenever a vehicle is unattended
Unauthorized Firearms are prohibited on the Giant Mine property
The Possession of Alcohol or Illegal Drugs is prohibited on Giant Mine property
The use of Entertainment Equipment with Earphones is prohibited on work sites
Fall Arrest Training and Equipment is required for working at heights above 1.82m (6 feet)
Arial Work Platform certification is required prior to the use of any lift device
Lock Out/Tag Out Procedures are required for working on all equipment and machinery
Confined Space Entry Procedures are required when working in confined spaces
All Accidents, Incidents, Near Misses and Environmental Spills of any sizes are to be reported to a Nuna Logistics Representative promptly.
All work on site must be covered by a Site Specific Safety Plan, or Standard Work Procedure which is equivalent to or surpasses the standard set by the Care and Maintenance Contractor.



Personal Protective Equipment Requirements

Hard hats – CSA approved with side impact protection
Fiber-metal hats may be used by pipefitters, scaffolders and welders
Steel Toe Boots – CSA approved with 6 inch minimum ankle support

Eye Wear – CSA approved safety glasses to be worn at all times
Long Pants at all times or Coveralls if job requires
Long Shirts and Gloves suited for task
Safety Vest – CSA approved orange or lime green (or equivalent coveralls)
Engineered Fall Prevention/Arrest - as required by task
Site Supervisor to carry 2-way radio on site channel at all times
Any other job specific PPE as duties require

Work Permitting

All work activities taking place on the Giant Mine Site are subject to Nuna Logistics' Work Permitting Process which is administered by the Nuna Safety Department.
Moderate Risk Projects require a General Work Permit which is issued for a maximum of 28 days, and is checked daily by a Nuna Safety Officer.
High Risk Work is subject to the issuance of daily work permits which include the following
<ul style="list-style-type: none"> • Hot Work – Welding or Grinding • Working at Heights – Aerial Work Platforms, Fall arrest or Fall Protection above 1.8m • Confined Space – Tank, Vessel, vault or area not intended for human occupancy • Cranes and Hoisting – Mechanically rigging, moving or lifting a load • Electrical – Work on equipment potentially energized with over 120V potential • Ground Disturbance – Digging over 15cm of depth. • Environmental – Potential release of contaminants or dangerous substances • Blasting and Explosives – Any possession, movement or use of explosives
