## Amendment 002

The purpose of this amendment is to answer questions from potential bidders.

*Note: For answers to questions 1 to 5, please consult the previous amendment.*

**Question 6:**

We have further studied on the new requirements of the laboratory tests on colourfastness and staining of the felt. We found out that the colourfastness requirements are acceptable but the staining of the felt requirements are too high and not realistic.

Under this limitation, we hereby request the Technical Authority of this solicitation should review the requirement levels of the laboratory tests for staining of the felt.

**Answer:**

We revised the colourfastness testing requirements for Solicitation 21120-152534/B (in accordance with *ISO 11640:2012: Leather – Tests for Colourfastness – Colourfastness to cycles of to-and-fro Rubbing*) to include the test results for both the change in colour of the suede and the staining of the felt.

In the original tender (21120-152534/A) we had only included the testing for the staining of the felt. At bid evaluation it was brought to our attention that both test results were required for this test method in order to properly evaluate the test results.

We consulted with a testing laboratory in order to confirm the acceptable levels of colourfastness. The testing laboratory recommended a laboratory test result of no lower than 3 for the staining of the felt.

Therefore, the requirement levels of the laboratory tests for the staining of the felt will remain unchanged.
