The purpose of this amendment is to add Addenda, attached separately; to answer questions, and to replace the "BID AND ACCEPTANCE FORM", as follows:

QUESTIONS AND ANSWERS:

Q2. Is the existing concrete pad to be removed?

A2. Yes

Q3. What type of controls are to be used, Honeywell or Andover?

A3. Honeywell.

Q4. The sewer leaving the sub basement actually has a 45 degree elbow imbedded in the wall, the drawings show it leaving the building straight, with the 45 approximately 3' out.

A4. The drawings are based on the survey plan. Refer to attached mechanical addendum for clarification.

Q5. What is the scale on the drawings/C2.0 drawing?

A5. Original plot was 1:150 but skew during printing is possible. Contractor should verify scale using dimensions labeled on C2.0.

Q6. Are paving areas to be light duty asphalt?

A6. Yes.

Q7. Are any curbs to be installed?

A7. No.

Q8. Is there a known or estimated thickness of the existing slab to be removed where the old transformers were located?

A8. No.

Q9. Access to the site is over top of a tunnel of which is questionable in terms of its structural integrity. Is there any concern with the construction traffic materials, etc. traveling over this area?

A9. An alternate route has been determined and a drawing with that information is attached separately.

Q10. For the scissors lift, do you really need 15,000 lbs. capacity? If not 8,000 lbs capacity is possible with a double scissor.

A10. The crane has a 5 ton (11,200 lbs) capacity, so the lift will need to support anything the crane lifts. If there is a lift that will support 12,000 lbs, that would work.

Q11. Does the scissors lift need 83" of vertical travel?

A11. Yes, as it must reach from the lowered height to the height of the truck bed. See dimensions in drawings. The truck bed is 4' from the grade, and from the grade to the lowered height of the lift is 2'11", which is a total of 83".

Q13. If piles are encountered under the slab to be removed, can they be left, or addressed as a change after the fact?

A13. They are to be removed. See the request for separate pricing on the pile removal on the replacement "BID AND ACCEPTANCE FORM", as the exact number of piles is unconfirmed.
