Questions and Answers:

Q#1: What is expected work window?

A#1: 25May-14June (firm) all work must be completed by June 14th, the ship is in port sometime before the previous weekend, therefore hoarding may commence as soon as the ship returns.

Q#2: Is hoarding required?

A#2: Yes, subcontractor must have security clearance. Should a contractor not be cleared, a commissionaire may be requested to provide escort. Contractor can no longer escort subcontractors.

Q#3: Are there expected disruptions during work period?

A#3: The gun barrel and CIWS barrel will be removed early in the work period and returned later in the period. Some crane work may cause some minor disruptions.

Q#4: This specification states to exclude the 57mm Gun Ring (Cartridge Case Saveall) and associated deck and the Breakwater. Cleaning and treating of the stanchion bases is also excluded from this spec. 1)-Does this means that we do not need to prep up the gun ring and waterbreak.2)-What of the stanchion bases, they are in bad shape?

A#4: 1) Due to the short window, DEA has agreed to allow the prep only to the weld, and feather accordingly, this is to maintain the paint system water membrane. The 2" up the structure and 6" up deck attachments still applies -2) The stanchion base need to be included in the P&P.

Q#5: It is not clear that the interior deck of the gun ring is being done. The deck has visible metal exposure?

A#5: The cartridge case saveall deck will be time opportunity work, this area is not included in the bid. Time permitting, a WER may be entertained.

Q#6: To reduce ingress of contaminants to the ship, Can we get permission to have a private brow?

A#6: DND may be able to accommodate this request, however a commissionaire will be require to maintain ship security, the brow will need to be deactivate during silent hours.

Q#7: Will DND provide temporary vent/lights?

A#7: Yes, in both cases. If DND is unable to provide these services, the contractor will be permitted to use their equipment.

Q#8: The specification lists for Code C415 Biodegradable Cleaner, Sherwin Williams Green solv G-Max 308, this is a cleaner for wood decks. Is this correct or would you prefer another product from Sherwin Williams?

A#8: This is the wrong product code. The product is GMAX 328.
