#### Question 4:

Stream 1 Resource requirement - Under this stream, there is a requirement for a "Developer OTIC Specialist". Experience chows that the data migration to OpenText ECM does not always require the use of the OpenText InfoFusion Integration Centre (OTIC). By specifying OTIC requirements, the CMHC risks limited the number of proponents that have the necessary expertise to submit a compliant bid. Would CMHC consider opening the resource requirement to any demonstrated solution for this data migration?

### Question 8:

Under requirement 3.3.6.14 (HTML 5), this standard was only formalized on October 28, 2014 (<a href="http://www.w3.org/TR/html5/">http://www.w3.org/TR/html5/</a>). Thus the point rating for this requirement does not reflect industry. It is suggested that CMHC remove this requirement or replace HTML 5 with HTML.

## Response:

1. Page 59 Rated Requirement Item # 3.3.6.14 is now replaced with the following rated requirement: 'The Proponent should demonstrate that the proposed resource has experience in using HTML version 4.0 or higher.' The ratings stay the same.

### Question 9:

The current due date requested by the client will pose a significant issue for Suppliers. Would CMHC please consider granting an extension of two (2) weeks which will benefit the client in three ways: matching the best available resource to the requirement, increased participation from Suppliers, and higher quality proposals will result in more compliant choices for the client.

#### Response:

No extension is being granted as CMHC feels 4 weeks is sufficient time for vendors to provide a response.

#### Question 10:

With regard to Stream 1 – IM Business Analyst – Intermediate, Rated #3.2.2.10 states that for more than 5 years, the candidate would score 5 pts; however, in the table on page 24 of the

RFP, the Points available column shows a scale of 1-10. Would CMHC please confirm if 5 pts is the correct score for this rated?
