Addendum 2.

1. QUESTIONS AND ANSWERS

Q1. In Section 01 01 01 - 1.3 Head Harbour floats to be delivered to Ingalls head NB. Is this correct?

A1. North Head Floats to be delivered to Ingalls Head.

Q2. In Section 06 49 30 – 3.3 Decking is to be secured using 150mm long spikes, drawings show 150mm long lagscrews, which is correct?

A2. Decking to be secured using 150mm long lagscrews.

Q3. Does the interfloat connection on new floats come in pair (2 pieces, one on new float and one on existing) complete with the rubber unit?

A3. There are new interfloat connections required at both ends of floats except only one end on End and Type 1 floats. Each end requires a pair therefore four(4) total except End and Type 1 floats require two(2). There are no existing floats to be connected to.

Q4. How many lag screw do we use at each stringer to attach decking?

A4. There are two(2) lags required at ends of pieces of decking and one(1) lag at each stringer crossed.

Q5. On page 3 of 5, yoke detail show a PL 200x250x12 (round bar welded on) and on the section C it show the same piece at 200x250x19. Could you rectify?

A5. Plate size to be 200x250x19 mm

Q6. In the Tender Document under; Measure and Payment, Section 01 22 00, Page 1, 1.2 Description of Work, it states “complete supply and installation of the work”. Am I correct in thinking that this Tender is for Supply and Delivery on Land to each Site?

A6. The tender is for supply and delivery on land, that is correct.
