Questions and Answers regarding the solicitation

Q1) Please advise if the RCMP will supply heavy materials and a vehicle. This obviously effects our costing.

A1) The RCMP will provide the vehicle to bring the exhibits to the detachments. The Contractor's personnel will only have to arrive on scene through their own transportation. When required to cleanup a marijuana grow site, the Contractor's personnel will be required to bring typical safety equipment required are Safety Glasses, Gloves, Safety Boots and Dusk Mask.

Q2) Also, on the certifications part 5 RFP, do we simply say we are certified on each section or do we have to produce documentation?

A2) For the Certification section, the bidder must truthfully answer the questions asked in the section. They can cut and paste the questions from the bid solicitation to add it to their proposal. If there is a requirement to produce certification as stated in the mandatory or point-rated technical criteria the bidder must provide the certification or else their bid may be deemed unresponsive. Canada has the right to verify any certification documents that has been submitted.
